Virtual Occupational Therapy started last week and went well. Students were engaged. Mrs. Black conducted an observation with Mrs. Shoemaker for an incoming kindergarten student in the pre-school setting.

Mr. Best said as a follow-up to the question asked last month regarding community service ideas here at the school, student can help with youth sports, run lines for soccer games, volunteer for after school events (music concert, science fair, bingo night), help the janitorial staff, help with spring clean up in the yard, help booster club at sporting events and tutor younger students on Mondays after school. The secondary building completed their severe weather drill today and spring sports season is upon us and the first round of scrimmages were postponed today due to the weather. Mr. Best also introduced Mrs. Stepler, business teacher, to the Board.

Mrs. Shoemaker said registration for the Science Fair ended March 10, 2023. There are 57 participants: 31 elementary and 26 middle school. The Science Fair will be March 22, 2023, with set-up and judging in the afternoon. The public viewing will be 6:30-7:00 p.m. with the awards ceremony at 7:00 p.m. 25 students have registered for kindergarten in the fall; therefore, we will have two kindergarten classes and K-3 MIOSM Concert is March 21, 2023 at 7:00 p.m. in the high school gym. Teachers are reviewing potential phonics and phonemic awareness supplemental and intervention materials. Mrs. Shoemaker also gave a big thank you to UPVPC and their Rooted Youth for sharing two large trays of treats to the elementary staff and a note thanking us for all our care and compassion and for all we do for students. She also gave a big thank you to the Path Valley PennDOT crew for removing the cinders from the elementary playground areas.

Dr. Will informed the Board that the Athletic Banquet has been scheduled for Wednesday, May 10, 2023 at 6:00 p.m. and the Academic Banquet has been scheduled for Monday, May 15, 2023 at 6:00 p.m. A Save the Date went out last week. The 2023-2024 school calendar is on the agenda for approval. It is aligned with the Franklin County Career and Technical Center calendar and had input from the professional development committee and aligns with professional development needs of the district. It has one early dismissal day, four in-service days, three Act 80 days and three snow make up days with one free day to be used first then switch to remote learning to allow student to play in the snow. Dr. Will also gave an update on the dug-out. The goal is to be done soon. The roof is the only thing that still needs completed.
